- Fair Price – Workers are guaranteed minimum floor pricing and an additional premium for certified organic products.\*
- Fair Labor Conditions – Workers enjoy freedom of association, safe working conditions, and living wages. Forced child labor is strictly prohibited.\*
- Direct Trade – Importers purchase from Fair Trade products as directly as possible, eliminating unnecessary middlemen and empowering workers to develop their businesses to compete in the global marketplace.\*
- Environmental Sustainability – Harmful agrochemicals and GMOs are strictly prohibited in favor of environmentally sustainable farming methods that protect farmers’ health and preserve valuable ecosystems for future generations.\*

- Made from post-consumer recycled materials
- Made from widely recyclable materials – paper, newspaper, cardboard, #1 & 2 plastics, aluminum, steel, glass, foil
- Made in a manner that is environmentally sustainable and respectful – without pesticides or hormones, without taking from the planet that which cannot be replenished in a reasonable time-frame, without jeopardizing the health of any worker, without child labor, without animal testing, purchased for a fair wage, in a manner that treats male and female workers as equal contributors, and/or certified organic
